104.1 KRBE's "2019 GRAMMY TRIP PROMOTION" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC, 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

- g] One (1) time on Thursday, January 31, 2019 between the hours of 7:00 p.m. and 10:00 p.m. for one (1) 2019 Grammy Nominees Album.
- h] One (1) time on Friday, February 1, 2019 between the hours of 6:00 a.m. and 10:00 a.m. for one (1) 2019 Grammy Nominees Album.
- (ii) Text: Listen to the Station during the times stated below during the Contest Period. When the Station plays the "cue-to-text" and reveals the designated KEYWORD, listeners should send a text message with the KEYWORD to 37530. - f] One (1) time on Thursday, January 31, 2019 between the hours of 10:00 a.m. and 3:00 p.m. for one (1) 2019 Grammy Nominees Album.
- g] One (1) time on Thursday, January 31, 2019 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) 2019 Grammy Nominees Album.
- h) Two (2) times on Friday, February 1, 2019 between the hours of 10:00 a.m. and 3:00 p.m. for one (1) 2019 Grammy Nominees Album.
- (iii) Online: Visit the Station's website www.KRBE.com during the Contest Period, click on the "Contest" link, click on the ""2019 GRAMMY TRIP PROMOTION" Contest link. All entries must be received by 11:59 a.m. CST on Friday, February 1, 2019 to be eligible for the Prize. Limit one (1) entry per person per day per email address. Winner of the Grand Prize will be selected and called on Friday, February 1, 2019, b 3:30 PM CT. ARV: TWO THOUSAND AND FIVE HUNDRED DOLLARS (\$2,500).
