104.1 KRBE's "FLETCHER STUDIO 104" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE "FLETCHER STUDIO 104"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

All entries must be received by 11:59:00 pm CST on March 2, 2019 to be eligible to win an Online Qualifying Prize. Limit one (1) entry per person per day per email address. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. The Station will select a winner via random drawing of all valid entries. Failure to respond to the initial verification contact within 24 hours of notification will result in disqualification. Four (4) person(s) will qualify through this method.
