

**104.1 KRBE'S "PINK TRIP GIVEAWAY 2019" CONTEST
OFFICIAL RULES**

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC. or one of its subsidiary companies, 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE "PINK TRIP GIVEAWAY 2019"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age twenty-one (21) years of age or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days. **Void where prohibited by law.** Employees of Susquehanna Radio LLC., its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest will begin at **12:00 p.m., CT on March 9, 2019** and will run through **4:00 p.m., CT on March 25, 2019** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.** To enter:

(i) **On-Air:** Listen to the Station during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 713-390-5723. The designated Caller, as announced and determined by the Station in its sole discretion, will be entered to win. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. ***Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:*** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

Listeners will be able to call during this timeframe for a chance to win:

c] One (1) time on Thursday, March 14, 2019 between the hours of 10:00 a.m. and 3:00 p.m. for one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV is one-hundred fifty dollars (\$150).**

d] One (1) time on Friday, March 15, 2019 between the hours of 6:00 a.m. and 10:00 a.m. for one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV is one-hundred fifty dollars (\$150).**

e] One (1) time on Friday, March 15, 2019 between the hours of 7:00 p.m. and 9:00 p.m. for one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV is one-hundred fifty dollars (\$150).**

- (ii) **Text:** Listen to the Station during the Contest Period during the times stated below. When the Station plays the “cue-to-text” and reveals the designated KEYWORD, listeners should send a text message with the KEYWORD to 37530. The entry received within ten (10) minutes after the designated KEYWORD is announced, spelled correctly, and that is the one hundred fourth (104th) entry will be eligible for the prize. If the Station does not receive a minimum of 104 entries within the ten (10) minute timeframe, then the Station will randomly choose a texter from all valid entries during that timeframe to be the winner of the prize. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. ***Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:*** Due to the time delay that exists between the Station’s analog over-the-air signal and the Station’s online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station’s analog over-the-air signal. As a result, the odds of an online listener entering this Sweepstakes on-air may be diminished. **Standard text messaging rates, as established by an individual’s wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. By entering using this method, you consent to the receipt of a bounce-back confirmation text. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number.** Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes. Entrants to a text-to-win contest do not provide detailed personal information at the time of entry given the limitations of the text message format, but the winner(s) must provide all requested information at the time the winner(s) is selected and notified. Such information may include: including first and last name, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth.

Listeners will be able to text a designated keyword during these timeframes for a chance to win:

b] Two (2) times on Saturday, March 16, 2019 between the hours of 10:00 a.m. and 3:00 p.m. for one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV is one-hundred fifty dollars (\$150).**

c] Two (2) times on Saturday, March 16, 2019 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV is one-hundred fifty dollars (\$150).**

d] Two (2) times on Sunday, March 17, 2019 between the hours of 10:00 a.m. and 2:00 p.m. for one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV is one-hundred fifty dollars (\$150).**

e] Two (2) times on Sunday, March 17, 2019 between the hours of 2:00 p.m. and 7:00 p.m. for one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV is one-hundred fifty dollars (\$150).**

(iii) On-Site: Attend a remote broadcast conducted by the Station. Station will have a register-to-win contest at Houston area MetroPCS stores stated below. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.

Listeners will be able to complete an entry form during these timeframes for a chance to win:

4. **Winner Selection. Winner Selection.**

(i) **On-Air:** The designated caller (as described above) and as determined by the Station in its sole discretion, may be awarded the Qualifying prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. There will be five (5) qualifiers through this method.

(ii) **Text to win:** The one hundred fourth (104th) texter (as described above) and as determined by the Station in its sole discretion, may be awarded the Qualifying prize (subject to verification of eligibility and compliance with the terms of these rules). The winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules or the specific Contest rules). There will be nine (9) qualifiers through this method.

(iii) Onsite: On or about 2:00 p.m. CT on Saturday, March 9, 5:00 p.m. CT on Saturday, March 16, and 2:00 p.m. CT on Saturday, March 23, 2019, Station will select three (3) entries per remote broadcast event on those dates for the Qualifying Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be announced and/or contacted using the telephone number provided with the entry at each remote broadcast, as Qualifiers must be present to be awarded the Qualifying prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) hour of notification will result in disqualification.

Grand Prize Winner Selection. On or about 4:00 p.m. CT on Monday, March 25, 2019, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid qualifiers received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the

potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) hour of notification will result in disqualification.

5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.
6. **Prizes Offered. Qualifying Prizes.** Up to twenty-three (23) Qualifying Prizes will be awarded in this Contest: **a)** Fourteen (14) Qualifying Prizes from the On Air and Text contest methods will consist of one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002. **ARV: ONE HUNDRED FIFTY DOLLARS (\$150).** **b)** Six (6) Qualifying Prizes from the first two (2) On-Site events will consist of one (1) pair of tickets [2 tickets] to see Pink on March 19, 2019 at Toyota Center, 1510 Polk Street, Houston, TX 77002 and a pair of seats on the Pink Party bus (roundtrip transportation from KRBE, 9801 Westheimer, Suite 700, Houston, Texas, 77042 to Toyota Center, 1510 Polk Street, Houston, TX 77002). **ARV: THREE HUNDRED DOLLARS (\$300).** **c)** Three (3) Qualifying Prizes from the last On-Site event will consist of one (1) \$300 VISA Gift Card and a merchandise prize pack. **ARV: THREE HUNDRED TWENTY DOLLARS (\$320).**

Grand Prize. **One (1) Grand Prize** will be awarded in this Contest. The Grand Prize is a trip for two (the winner and a guest) to the Pink Show on April 12, 2019 at T-Mobile Arena, 3780 S. Las Vegas Blvd, Las Vegas, Nevada, 89158, which consists of round-trip coach airfare for two (2) to Las Vegas, NV, two (2) nights single room, double occupancy of lodging at MGM Grand Las Vegas, at 3799 S Las Vegas Blvd, Las Vegas, Nevada, 89109, and two (2) tickets to the Pink Show on April 12, 2019. Winner of the Grand Prize will be selected and called on Monday, March 25, 2019, at approximately 4:00 PM CT. **ARV: TWO THOUSAND DOLLARS (\$2,000).** Winner is responsible for all taxes associated with prize receipt and/or use, expenses for travel to and from departing/arriving airport, lodging, and/or event, and any taxes or incremental fees associated with lodging expenses. Odds of winning a Qualifying Prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time. Odds of winning the Grand Prize are one in twenty-three.

Grand Prize Trip must be taken between April 11 – April 15, 2019, on a travel itinerary at the sole discretion of the Station. Should the winner be unable to travel for any reason on the confirmed date when notified, then the Winner forfeits the Grand prize and at that time the Station may, in its sole discretion, randomly select an alternate Winner out of the remaining qualifiers. Winner and guest must travel on the same itinerary. Guest must be 21 years of age or over, in order to accompany the Winner. Grand Prize Trip is non-transferable and no substitution will be made except as provided herein at the Station's sole discretion.

7. **Entry Conditions and Release.** By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Cumulus Media Inc., and its subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and

all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use, non-use or misuse of the prize.

10. **General Conditions.** Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
12. **Disputes.** Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or

conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

13. **Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
