# 104.1 KRBE'S "SUMMER SLOT \$10k JACKPOT JULY 2019 PROMOTION" OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., or one of its subsidiary companies, 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE's "SUMMER SLOT \$10K JACKPOT JULY 2019 PROMOTION"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years of age or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days. Void where prohibited by law. Employees of Susquehanna Radio LLC., its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. Only one (1) person per immediate family member and/or household member may qualify in this Contest. Once there is a qualifying winner in a household or immediate family member other members are not eligible to participate and will be disqualified.

- 2. Contest Period. The Contest will begin at 8:00 a.m., CT on July 1, 2019 and will run through 5:00 p.m., CT on August 4, 2019 (the "Contest Period"). This Contest will NOT be conducted on Independence Day, Thursday, July 4, 2019 and Friday, July 5, 2019 due to KRBE Holiday schedule. The Station's computer is the official time keeping device for this Contest.
- **3. How to Enter.** To enter:
  - (i) <u>On-Air Text</u>:

Listen to the Station during the Contest Period during the times stated below. When the Station plays the "cueto-text" and reveals the designated KEYWORD, listeners should send a text message with the KEYWORD to 37530. The entry received within ten (10) minutes after the designated KEYWORD is announced, spelled correctly, and that is the one hundred fourth (104th) entry will be eligible for the prize. If the Station does not receive a minimum of 104 entries within the ten (10) minute timeframe, then the Station will randomly choose a texter from all valid entries during that timeframe to be the winner of the prize. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. Time Delay Between Overthe-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Sweepstakes on-air may be diminished. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. By entering using this method, you consent to the receipt of a bounce-back confirmation text. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes. Entrants to a text-to-win contest do not provide detailed personal information at the time of entry

given the limitations of the text message format, but the winner(s) must provide all requested information at the time the winner(s) is selected and notified. Such information may include: including first and last name, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth.

Listeners will be able to text the designated keyword during these timeframes every weekday during the Contest Period between the hours of: 8:00 a.m. and 9:00 a.m., 11:00 a.m. and 12:00 p.m., 2:00 p.m. and 3:00 p.m., 4:00 p.m. and 5:00 p.m., and 5:00 p.m. and 6:00 p.m. There will be a designated prize for each date/day/time, i.e. each time the keyword is announced, **as outlined in Appendix A**, for a total of one hundred and twenty (120) Qualifying Prizes through this contest method.

(ii) **On-Site:** Attend a remote broadcast conducted by the Station. Station will have a register-to-win contest at select locations stated below.

**Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast. Listeners will be able to complete an entry form during these timeframes for a chance to win:

c] Between the hours of 7:00 p.m. and 9:00 p.m. on Friday, July 19, 2019 at Katy Vibes, 24757 Katy Freeway, Katy, Texas, 77494, for one (1) one hundred and four dollars (\$104) American Express Gift Card. **ARV: one hundred and four dollars (\$104)**.

d] Between the hours of 12:00 p.m. and 2:00 p.m. on Saturday, July 20, 2019 at Skechers store, 8460 Gulf Freeway, Houston, Texas, 77017, for one (1) one hundred and four dollars (\$104) American Express Gift Card and one (1) fifty dollars (\$50) Skechers gift card . **ARV: one hundred and fifty-four dollars (\$154).** 

e] Between the hours of 3:00 p.m. and 5:00 p.m. on Saturday, July 27, 2019 at Skechers store, 6518 Westheimer Road, Houston, Texas, 77057, for one (1) one hundred and four dollars (\$104) American Express Gift Card and one (1) fifty dollars (\$50) Skechers gift card. **ARV: one hundred and fifty-four dollars (\$154)**.

There will be three (3) Qualifying Prizes (a \$104 American Express gift card) chosen through this method – two (2) Qualifying Prizes at Katy Vibes and one (1) Qualifying Prize at Houston Museum of Natural Science. ARV: one hundred and four dollars (\$104).

There will be three (3) Qualifying Prizes at the designated Skechers store (a \$104 American Express gift card and \$50 Skechers gift card) chosen through this method (one [1] per store). ARV: one hundred and fifty-four dollars (\$154).

(iii) On Site Finale Event "Last Chance Registration": Attend the finale remote broadcast event conducted by the Station and participate in the register-to-win contest to receive the "Last Chance" Qualifying Prizes at Skechers Humblewood Shopping Center location, 19739 Highway 59, Humble, Texas, 77338, between the hours of 1:00 pm and 2:20 pm on Sunday, August 4, 2019. Limit one (1) entry per person. All entries must be received by 2:20 p.m.

There will be two (2) Qualifying Prizes (a \$104 American Express gift card) chosen through this method. ARV: one hundred and four dollars (\$104).

#### 4. Winner Selection.

Qualifiers, their immediate family members and/or household members can only win by one (1) contest method only and have only one (1) entry for the Grand Prize. Only one (1) person per immediate family member and/or household member may qualify in this Contest.

(i) <u>On-Air:</u> The one hundred fourth (104<sup>th</sup>) texter (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Texter will be notified at the time of Station's callback. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in

all matters related to the Contest. There will be a minimum of one hundred and fifteen (115) qualifiers through this method.

- (ii) Onsite: On or about, 2:05 p.m. CT on Saturday, July 13, 2019, 2:05 p.m. CT on Sunday, July 14, 2019, 9:05 p.m. Friday, July 19, 2019, 2:05 p.m. Saturday, July 20, 2019, and 5:05 p.m. CT on Saturday, July 27, 2019, the Station will select a total of six (6) entries from the remote broadcast events on the dates outlined above for the Qualifying Prize in a random drawing among all valid entries received by station during the Contest Period. The winning entrant will be announced and/or contacted using the telephone number provided with the entry at each remote broadcast. Qualifiers do not need to be present to be awarded the Qualifying prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) hour of notification will result in disqualification. There will be a minimum of six (6) qualifiers through this method.
- (iii) On Site Finale Event "Last Chance Registration": On or about 2:25 p.m. CT on Sunday, August 4, 2019, Station will select two (2) entries for the Qualifying Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be announced and/or contacted using the telephone number provided with the entry the On Site Finale Event, as Qualifiers must be present to be awarded the Qualifying prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within ten (10) minutes of notification will result in disqualification. There will be a minimum of two (2) qualifiers through this method.

**Grand Prize Winner Selection.** On Sunday, August 4, 2019, all Qualifiers will be required to attend the Grand Prize event from 1:00 p.m. to approximately 5:00 p.m. at Skechers store, 19739 Highway 59, Humble, Texas, 77338, to play the "Summer Slot 10K Jackpot" activity in order to win the grand prize. All participating Qualifiers must check in at KRBE's Qualifiers table between 1:00 p.m. and 2:25 p.m. with a current, valid government-issued photo ID and fill out station paperwork. Once checked-in, the Qualifier will then randomly choose a number between 1 and 121 to determine their designated place in line to participate in the "Summer Slot 10K Jackpot" activity. If a Qualifier does not complete the check-in process by 2:25 p.m. and/or does not present a current, valid government issued photo ID, then the Qualifier forfeits the right to participate in the "Summer Slot 10K Jackpot" activity and the chance to win the Grand Prize and at that time will no longer be qualified to win the Grand Prize. NO PROXIES WILL BE ALLOWED FOR ANY REASON. ONCE CHECKED-IN A QUALIFIER MUST REMAIN PRESENT IN ORDER TO WIN. A QUALIFIER WHO HAS CHECKED-IN, BUT WHO DOES NOT PRESENT HIMSELF/HERSELF WITHIN THIRTY (30) SECONDS WHEN IS/HER NAME OR NUMBER IS CALLED, AS DETERMINED IN THE STATION'S SOLE DISCRETION, WILL BE DEEMED NO LONGER PRESENT AND IS NO LONGER ABLE TO WIN THE GRAND PRIZE.

After every Qualifier has checked in and been verified, any numbers remaining from 1 to 121 that was not randomly chosen by a Qualifier will be voided and then skipped during the "Summer Slot 10K Jackpot" activity. The last two (2) Qualifiers from the On Site Finale Event will then be given number 122 and 123 respectively based on the order their entry form was randomly selected. Starting at approximately 2:30 p.m., each Qualifier - in numerical order from 1 to 123 – will get two consecutive (2) plays (via a push button and/or pull lever as selected by the Qualifier) on a full size, casino-style, custom slot machine to randomly receive points (based on a scoring key displayed at the event). A KRBE representative, designated as the Official Scorer, will tabulate all points per Qualifier and log the points on an official score card. The Qualifier with the most points at the end of the "Summer Slot 10K Jackpot" activity will be the Grand Prize Winner. In the case of a point tie, those participants who have the same amount of points will start over and get another two (2) consecutive plays on the slot machine to get a new point score. (Previous points will not be counted in tie Breaker Rounds). - v. 104.1 KRBE Logo: 104 points

# vi. Blank or White Space (where no images or logos are touching/crossing the "payline"): Zero (0) points

The winning entrant will be announced at the event and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.

e] Two (2) Qualifying Prizes from the On Air contest method will consist of one (1) four-pack of tickets [two (2) tickets] to Six Flags Fiesta Texas, at Six Flags Fiesta Texas, 17000 W IH 10, San Antonio, Texas 78257. ARV: three hundred dollars (\$300).

f] Seven (7) Qualifying Prizes from the On Air contest method will consist of one (1) pair of tickets [two (2) tickets] to Austin City Limits Music Festival Weekend 1 on Saturday, October 5 or Sunday, October 6, 2019, to be determined by station, at Zilker Park, 2100 Barton Springs Rd, Austin, Texas 78704. **ARV: two hundred and ten dollars (\$210).** 

g] Three (3) Qualifying Prizes from the On Site Event contest method will consist of one (1) \$104 American Express Gift Card. **ARV: one hundred and four dollars (\$104).** 

h] Three (3) Qualifying Prizes from the On Site Event contest method at Skechers will consist of one (1) \$104 American Express Gift Card and one (1) \$50 Skechers Gift Card. **ARV: one hundred and fifty four dollars** (\$154).

i] Two (2) Qualifying Prizes from the On Site Finale Event "Last Chance Registration" contest method will consist of one (1) \$104 American Express Gift Card. **ARV: one hundred and four dollars (\$104).** 

<u>Grand Prize</u>. One (1) Grand Prize will be awarded in this Contest. The Grand Prize is \$10,000 in the form of a company check and a \$100 Skechers Gift Card. ARV: Ten-thousand and one hundred dollars (\$10,100). Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning a Qualifying Prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time. Odds of winning the Grand Prize are one in one hundred and thirty.

Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 11. Limitations of Liability. The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
