

**104.1 KRBE’S “2019 ROULA & RYAN ROAD SHOW VEGAS TRIP GIVEAWAY PROMOTION” CONTEST
OFFICIAL RULES**

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE (“Station”), owned and operated by Susquehanna Radio LLC., 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE’S “2019 ROULA & RYAN ROAD SHOW VEGAS TRIP GIVEAWAY PROMOTION”** Contest (the “Contest”) substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number and who reside in the Station’s Designated Market Area (“DMA”) as defined by Nielsen Audio, **Void where prohibited by law.** Employees of Susquehanna Radio LLC., its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station’s DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term “immediate family members” includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term “household members” refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. **Only one (1) competitor per household.**

2. **Contest Period.** The Contest will begin at **3:00 p.m., CST on Friday, August 30, 2019** and will run through **11:59 a.m., CST on Friday, September 13, 2019** (the “Contest Period”). The Station’s computer is the official time keeping device for this Contest.

3. **How to Enter.** To enter:

On-Air:

When the Station plays the “cue-to-call” sounder, listeners should call the Station at 713-390-5723. The designated caller, as announced and determined by the Station in its sole discretion, will be entered to win. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station’s analog over-the-air signal and the Station’s online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station’s analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

Listeners will be able to call during these timeframes listed below for a chance to win:

- a] One (1) time on Friday, August 30, 2019 between the hours of 7:00 p.m. and 11:00 p.m. for one (1) pair of tickets [two (2) tickets] to The Roula & Ryan Road Show on Saturday, September 14, 2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: fifty dollars (\$50).**
- (ii) **Text-to-win:** Listen to the Station during the Contest Period during the times stated below. When the Station plays the “cue-to-text” and reveals the designated KEYWORD, listeners should send a text message with the KEYWORD to 37530. The entry received within ten (10) minutes after the

designated KEYWORD is announced, spelled correctly, and that is the one hundred fourth (104th) entry will be eligible for the prize. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Sweepstakes on-air may be diminished. **Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. By entering using this method, you consent to the receipt of a bounce-back confirmation text. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number.** Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes. Entrants to a text-to-win contest do not provide detailed personal information at the time of entry given the limitations of the text message format, but the winner(s) must provide all requested information at the time the winner(s) is selected and notified. Such information may include: including first and last name, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth.

c] Two (2) times on Saturday, August 31, 2019 between the hours of 2:00 p.m. and 7:00 p.m. for one (1) pair of tickets [two (2) tickets] to The Roula & Ryan Road Show on Saturday, September 14, 2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: fifty dollars (\$50).**

d] One (1) time on Sunday, September 1, 2019 between the hours of 10:00 a.m. and 2:00 p.m. for one (1) pair of tickets [two (2) tickets] to The Roula & Ryan Road Show on Saturday, September 14, 2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: fifty dollars (\$50).**

e] Two (2) times on Sunday, September 1, 2019 between the hours of 2:00 p.m. and 7:00 p.m. for one (1) pair of tickets [two (2) tickets] to The Roula & Ryan Road Show on Saturday, September 14, 2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: fifty dollars (\$50).**

f] One (1) time on Monday, September 2, 2019 between the hours of 10:00 a.m. and 2:00 p.m. for one (1) pair of tickets [two (2) tickets] to The Roula & Ryan Road Show on Saturday, September 14, 2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: fifty dollars (\$50).**

g] Two (2) times on Monday, September 2, 2019 between the hours of 2:00 p.m. and 7:00 p.m. for one (1) pair of tickets [two (2) tickets] to The Roula & Ryan Road Show on Saturday, September 14,

2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: fifty dollars (\$50).**

- (iii) **Online:** Visit the Station's website www.KRBE.com during the Contest Period, click on the "Contest" link, click on the "**2019 ROULA & RYAN ROAD SHOW VEGAS TRIP GIVEAWAY PROMOTION**" Contest link, and complete the entry form. All entries must be received by 11:59 a.m. CST on Friday, September 13, 2019 to be eligible for the Prize. **Limit one (1) entry per person per day per email address.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

4. **Winner Selection.**

Qualifiers, their immediate family members and/or household members can only win by one (1) contest method only and have only one (1) entry for the Grand Prize. Only one (1) person per immediate family member and/or household member may qualify in this Contest.

- (i) **On-Air and Texting:** The designated caller or texter (as described above) and as determined by the Station in its sole discretion, may be awarded the qualifying prize (subject to verification of eligibility and compliance with the terms of these rules). Texter will be notified at the time of Station's callback. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. On or about 12:00 p.m. CST on Tuesday, September 3, 2019, Station will select one (1) entry in a random drawing among all valid entries received by Station during the Contest Period to become Finalist #1. There will be a minimum of eleven (11) qualifiers through this method.
- (ii) **Online:** On or about 1:00 p.m. CST on Friday, September 13, 2019, Station will select one (1) entry in a random drawing from among all valid entries received by Station during the Contest Period to become Finalist #2. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (1) hour of notification will result in disqualification. There will be a minimum of one (1) qualifier through this method.

Grand Prize Winner Selection. On Saturday, September 14, 2019, both Finalists will be required to attend Grand Prize event [The Roula & Ryan Road Show] from 7:00 p.m. to 10:00 p.m. at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. All participating Finalists must be in their seats between 9:15 p.m. and 9:45 p.m. to be considered as a finalist for the Grand Prize. The two (2) finalists will play the "Road Show Slot Machine" activity in order to win the grand prize. If a Finalist is not present for the activity, then the Finalist forfeits the right to participate in the "Road Show Slot Machine" activity and the chance to win the Grand Prize and at that time will no longer be eligible to win the Grand Prize. Station may then select an alternate Finalist at its sole discretion. **NO PROXIES**

WILL BE ALLOWED FOR ANY REASON. THE FINALISTS MUST REMAIN PRESENT IN ORDER TO WIN. ANY FINALIST NOT PRESENT DURING THE ACTIVITY WILL BE DEEMED NO LONGER PRESENT AND IS NO LONGER ABLE TO WIN THE GRAND PRIZE.

Each Finalist will get two (2) consecutive plays with an additional four (4) consecutive plays from the assistance of two KRBE DJs (with each DJ getting two (2) plays each) [via a push button and/or pull lever] as selected by the Finalist and/or KRBE DJs on a full size, casino-style, custom slot machine to randomly receive points (based on a scoring key displayed at the event). A KRBE representative, designated as the Official Scorer, will tabulate all points per Qualifier and log the points on an official score card. The Finalist with the most points at the end of the “Road Show Slot Machine” activity will be the Grand Prize Winner. In the case of a point tie, the Finalists will start over and get one (1) additional play on the slot machine to get a new point score. (Previous points will not be counted in tie Breaker Rounds). This process will continue until one (1) Finalist is declared the grand prize winner based on the highest amount of points in that tie-breaking round.

Scoring of the “Road Show Shot Machine” will be done under the following designations when these images touch or cross the official “Payline” of the slot machine:

- i. Coin Image: 10 points
- ii. Money Bag Image: 20 points
- iii. Image of KRBE DJ: 30 points
- iv. Roula and Ryan Image: 40 points
- v. 104.1 KRBE Logo: 104 points
- vi. **Blank or White Space (where no images or logos are touching/crossing the “payline”): Zero (0) points**

The Grand Prize winner will be announced at the event and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station’s decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within seven (7) days of notification will result in disqualification.

5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within seven (7) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.
6. **Prizes Offered. Qualifying Prizes.** Eleven (11) total qualifying prizes will be awarded in this Contest. Each prize is one (1) pair of tickets [two (2) tickets] to The Roula & Ryan Road Show on Saturday, September 14, 2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: fifty dollars (\$50).**

Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning the prize depend on a number of factors including the number of eligible entries received during each “cue to call” sounder during the Contest Period and listeners participating at any given time.

Finalist Prizes. Two (2) total Finalist prizes will be awarded in this Contest. Each prize is one (1) pair of seats [two (2) passes] on the main stage of The Roula & Ryan Road Show on Saturday, September 14, 2019, at Revention Music Center, 520 Texas Ave, Houston, Texas 77002. **ARV: one hundred and sixteen dollars (\$116).**

Grand Prize. One (1) total Grand Prize will be awarded in this Contest. The Grand Prize is a trip to Las Vegas, Nevada for two (2) [the winner and guest], which consists of a round-trip coach airfare for two (2) to Las Vegas, NV, a two (2) night stay with single-room double occupancy of lodging in the Las Vegas, NV area as selected by the Station and two (2) tickets to the Alessia Cara concert on Friday, November 15, 2019 at The Chelsea at The Cosmopolitan of Las Vegas, 3708 Las Vegas Boulevard South, Las Vegas, NV 89109. **ARV: one thousand dollars (\$1,000).**

There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, at its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Any tickets and/or gift certificates/cards awarded as part of a prize will be subject to the terms and conditions set forth by the issuer and are valid only on the date(s) printed on the tickets or gift certificates/cards. Other restrictions may apply.

Grand Prize Trip must be taken sometime between November 14, 2019 and November 17, 2019, based on the final travel itinerary set by the Station. Should the winner be unable to travel for any reason on the confirmed date when notified, then the Winner forfeits the Grand prize and at that time the Station may, in its sole discretion, select an alternate Winner. Winner and guest must travel on the same itinerary. Guest must be 18 years of age or over, in order to accompany the Winner. If the Guest is under 21 years of age, then the Grand Prize Winner must be the legal guardian or parent of the guest selected. Grand Prize Trip is non-transferable and no substitution will be made except as provided herein at the Station’s sole discretion.

7. **Entry Conditions and Release.** By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Susquehanna Radio LLC., and its subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the “Released Parties”) from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant’s entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys’ fees) arising out of or relating to an entrant's participation in the Contest and/or entrant’s acceptance, use, non-use or misuse of the prize.

9. **Taxes.** All State, Local, Federal and/or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.
10. **General Conditions.** Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
12. **Disputes.** Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
13. **Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in

operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
