104.1 KRBE's "2019 AUSTIN CITY LIMITS MUSIC FESTIVAL WEEKEND 2 PROMOTION" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 104.1 KRBE "2019 AUSTIN CITY LIMITS MUSIC FESTIVAL WEEKEND 2 PROMOTION" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

- c] Two (2) times on Saturday, September 28, 2019 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) pair of passes [two (2) passes] in the form or wristbands to Austin City Limits Music Festival at Zilker Park, 2100 Barton Springs Rd, Austin, TX 78704, on October 11 13, 2019. **ARV: five hundred twenty dollars (\$520)**.
- d] One (1) time on Sunday, September 29, 2019 between the hours of 10:00 a.m. and 2:00 p.m. for one (1) pair of passes [two (2) passes] in the form or wristbands to Austin City Limits Music Festival at Zilker Park, 2100 Barton Springs Rd, Austin, TX 78704, on October 11 13, 2019. **ARV: five hundred twenty dollars (\$520)**.
- e] Two (2) times on Sunday, September 29, 2019 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) pair of passes [two (2) passes] in the form or wristbands to Austin City Limits Music

Festival at Zilker Park, 2100 Barton Springs Rd, Austin, TX 78704, on October 11 - 13, 2019. **ARV: five hundred twenty dollars (\$520)**.

- 4. **Winner Selection.** The designated caller or texter (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
- 5. Verification of Potential Winner. Winner is responsible for all taxes associated with prize receipt and/or use. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 11. **Limitations of Liability.** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
