104.1 KRBE's "BILLIE EILISH AT TOYOTA CENTER CONCERT WEEK 2019 PROMOTION" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 104.1 KRBE "BILLIE EILISH AT TOYOTA CENTER CONCERT WEEK 2019 PROMOTION" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days. Void where prohibited by law. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. - 2. Contest Period. The Contest will begin at 8:00 a.m., CST on Monday, October 7, 2019 and will run through 5:00 p.m., CST on Thursday, October 10, 2019 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
 - (i) On-Air: Listen to the Station during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 713-390-5723. The designated caller, as announced and determined by the Station in its sole discretion, will be entered to win. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- b] Three (3) times on Tuesday, October 8, 2019 between the hours of 8:00 a.m. and 5:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Billie Eilish concert on Thursday, October 10,

- 2019, at Toyota Center, 1510 Polk Street, Houston, Texas 77002. ARV: one hundred dollars (\$100).
- c] Three (3) times on Wednesday, October 9, 2019 between the hours of 8:00 a.m. and 5:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Billie Eilish concert on Thursday, October 10, 2019, at Toyota Center, 1510 Polk Street, Houston, Texas 77002. **ARV: one hundred dollars** (\$100).
- d] Three (3) times on Thursday, October 10, 2019 between the hours of 8:00 a.m. and 5:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Billie Eilish concert on Thursday, October 10, 2019, at Toyota Center, 1510 Polk Street, Houston, Texas 77002. **ARV: one hundred dollars** (\$100).
- 4. **Winner Selection.** The designated caller (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
- 5. Verification of Potential Winner. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. Odds of winning the prize depend on a number of factors including the number of eligible entries received during each "cue to call" sounder during the Contest Period and listeners participating at any given time.

Other restrictions may apply.
- 7. **Entry Conditions and Release.** By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Susquehanna Radio LLC., and its subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives

Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
