104.1 KRBE'S "POST MALONE AT TOYOTA CENTER CONCERT WEEKEND 2019 PROMOTION" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE "POST MALONE AT TOYOTA CENTER CONCERT WEEKEND 2019 PROMOTION"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - c] Two (2) times on Saturday, November 2, 2019 between the hours of 2:00 p.m. and 7:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Post Malone concert at Toyota Center, 1510 Polk Street, Houston, Texas 77002, on Tuesday, November 5, 2019. **ARV: two hundred dollars (\$200).**
- d] One (1) time on Sunday, November 3, 2019 between the hours of 10:00 a.m. and 2:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Post Malone concert at Toyota Center, 1510 Polk

Street, Houston, Texas 77002, on Tuesday, November 5, 2019. **ARV: two hundred dollars** (\$200).

- e] Two (2) times on Sunday, November 3, 2019 between the hours of 2:00 p.m. and 7:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Post Malone concert at Toyota Center, 1510 Polk Street, Houston, Texas 77002, on Tuesday, November 5, 2019. **ARV:** two hundred dollars (\$200).
- 4. **Winner Selection.** The designated caller or texter (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
