104.1 KRBE's "MAROON 5 ON-SALE TICKET WEEKEND 2019 PROMOTION" CONTEST OFFICIAL RULES

Eligibility. - d] One (1) time on Sunday, December 8, 2019 between the hours of 10:00 a.m. and 2:00 p.m. for one (1) pair of [two (2) tickets] to the Maroon 5 concert at Cynthia Woods Mitchell Pavilion,

2005 Lake Robbins Dr, The Woodlands, TX 77380 on Monday, June 8, 2020. **ARV** is eighty (\$80).

e] Two (2) times on Sunday, December 8, 2019 between the hours of 2:00 p.m. and 7:00 p.m. for one (1) pair of [two (2) tickets] to the Maroon 5 concert at Cynthia Woods Mitchell Pavilion, 2005 Lake Robbins Dr, The Woodlands, TX 77380 on Monday, June 8, 2020. **ARV** is eighty (\$80).

- 4. **Winner Selection.** The designated caller or texter (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
- 5.
