104.1 KRBE'S "CONCACAF WOMEN'S OLYMPIC QUALIFIER 2020 PROMOTION" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., or one of its subsidiary companies, 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 104.1 KRBE "CONCACAF WOMEN'S OLYMPIC QUALIFIER 2020 PROMOTION" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a current and valid government-issued identification and a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days. The designated Caller to the Station, as determined by the Station in its sole discretion, will be entered to win. If the Station does not receive a the designated number of entries within the ten (10) minute timeframe, then the Station will randomly choose a caller from all valid entries during that timeframe to be the winner of the prize. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. - c] One (1) time on Thursday, January 30, 2020 between the hours of 6:00 a.m. and 10:00 a.m. for one (1) four-pack of tickets [four (4) tickets] to the Concacaf Women's Olympic qualifying game United States vs. Panama at BBVA Stadium, 2200 Texas Ave, Houston, TX 77003 on Friday, January 31, 2020 at 7:30p.m. **ARV** is one hundred dollars (\$100).
- d] One (1) time on Friday, January 31, 2020 between the hours of 6:00 a.m. and 10:00 a.m. for one (1) four-pack of tickets [four (4) tickets] to the Concacaf Women's Olympic qualifying game United States vs. Panama at BBVA Stadium, 2200 Texas Ave, Houston, TX 77003 on Friday, January 31, 2020 at 7:30p.m. **ARV** is one hundred dollars (\$100).
- e] One (1) time on Monday, February 3, 2020 between the hours of 6:00 a.m. and 10:00 a.m. for one (1) four-pack of tickets [four (4) tickets] to the Concacaf Women's Olympic qualifying game United States vs. Costa Rica at BBVA Stadium, 2200 Texas Ave, Houston, TX 77003 on Monday, February 3, 2020 at 7:30p.m. **ARV** is one hundred dollars (\$100).
- 4. **Winner Selection.** The designated caller (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.

tickets [four (4) tickets] to the Concacaf Women's Olympic qualifying game [United States vs. Panama at BBVA Stadium on Friday, January 31, 2020 at 7:30p.m], at 2200 Texas Ave, Houston, TX 77003. **ARV is one hundred dollars** (\$100). There will be one (1) prize for the Concacaf Women's Olympic qualifying game [United States vs. Costa Rica at BBVA Stadium on Monday, February 3, 2020 at 7:30p.m] at 2200 Texas Ave, Houston, TX 77003. **ARV is one hundred dollars** (\$100).

Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning the prize depend on a number of factors including the number of eligible entries received during each "cue to call" sounder during the Contest Period and listeners participating at any given time.

- permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
