## 104.1 KRBE'S "HALSEY ON-SALE TICKET PROMOTION 2020" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., or one of its subsidiary companies, 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE "HALSEY ON-SALE TICKET PROMOTION 2020"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

- (ii) **Text:** Listen to the Station during the Contest Period during the times stated below. When the Station plays the "cue-to-text" and reveals the designated KEYWORD, listeners should send a text message with the KEYWORD to 37530. - c] One (1) time on Thursday, January 16, 2020 between the hours of 10:00 a.m. and 3:00 p.m. for one (1) pair of general admission lawn tickets [two (2) tickets] to the Halsey concert at Cynthia Woods Mitchell Pavilion, 2005 Lake Robbins Dr, The Woodlands, TX 77380 on Tuesday, June 16, 2020. **ARV** is eighty (\$80).
- d] One (1) time on Thursday, January 16, 2020 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) pair of general admission lawn tickets [two (2) tickets] to the Halsey concert at Cynthia Woods Mitchell Pavilion, 2005 Lake Robbins Dr, The Woodlands, TX 77380 on Tuesday, June 16, 2020. **ARV** is eighty (\$80).
- 4. **Winner Selection.** The designated caller or texter (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
