104.1 KRBE'S "HOUSTON ROCKETS VS THUNDER 1-20-20 GAME PROMOTION" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC., or one of its subsidiary companies, 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE "HOUSTON ROCKETS VS THUNDER 1-20-20 GAME PROMOTION"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - (i) On-Air: Listen to the Station during the Contest Period during the times stated below. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 713-390-5723. The designated Caller to the Station, as determined by the Station in its sole discretion, will be entered to win. If the Station does not receive a the designated number of entries within the ten (10) minute timeframe, then the Station will randomly choose a caller from all valid entries during that timeframe to be the winner of the prize. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

a] One (1) time on Wednesday, January 15, 2020 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Rockets vs Thunders game at Toyota Center, 1510 Polk St, Houston, TX 77002 on Monday, January 20, 2020. **ARV is one hundred and two dollars (\$102).**

b] One (1) time on Thursday, January 16, 2020 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Rockets vs Thunders game at Toyota Center, 1510 Polk St, Houston, TX 77002 on Monday, January 20, 2020. **ARV is one hundred and two dollars (\$102).**

c] One (1) time on Friday, January 17, 2020 between the hours of 10:00 a.m. and 3:00 p.m. for one (1) pair of tickets [two (2) tickets] to the Rockets vs Thunders game at Toyota Center, 1510 Polk St, Houston, TX 77002 on Monday, January 20, 2020. **ARV is one hundred and two dollars (\$102).**

- 4. **Winner Selection.** The designated caller (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
- Verification of Potential Winner. POTENTIAL CONTEST WINNER IS SUBJECT TO 5. VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner will be notified by email and/or telephone call after the date of random drawing and/or winner determination. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the Contest Prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. - 7. Entry Conditions and Release. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
