104.1 KRBE's "RODEOHOUSTON 2020 ON-SALE TICKET WEEK PROMOTION" CONTEST OFFICIAL RULES

The Station will conduct the **104.1 KRBE** "RODEOHOUSTON **2020 ON-SALE TICKET WEEK PROMOTION"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - c] One (1) time on Wednesday, January 15, 2020 between the hours of 10:00 a.m. and 3:00 p.m. for one (1) pair of [two (2) tickets] to see a designated artist at the 2020 Houston Livestock Show and Rodeo at NRG Stadium, NRG Pkwy, Houston, TX 77054. **ARV is forty dollars (\$40).**
- d] One (1) time on Wednesday, January 15, 2020 between the hours of 3:00 p.m. and 7:00 p.m. for one (1) pair of [two (2) tickets] to see a designated artist at the 2020 Houston Livestock Show and Rodeo at NRG Stadium, NRG Pkwy, Houston, TX 77054. **ARV is forty dollars (\$40).**
- 4. **Winner Selection.** The designated caller or texter (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call.
