104.1 KRBE'S "VIRTUAL STUDIO 104 FEATURING KANE BROWN WEEK OF 9/28" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station 104.1 KRBE ("Station"), owned and operated by Susquehanna Radio LLC 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **104.1 KRBE'S "VIRTUAL STUDIO 104 FEATURING KANE BROWN WEEK OF 9/28"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. (i) **On-Air:** Listen to the Station during the Contest Period from 10:00am CST through 7:00pm CST during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 713-390-5723. The designated Caller to the Station, as determined by the Station in its sole discretion, will be entered to win. If the Station does not receive the designated number of entries within the ten (10) minute timeframe, then the Station will randomly choose a caller from all valid entries during that timeframe to be the winner of the prize. The winning entrant will be contacted using the telephone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with the terms of these Contest Rules. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. **Up to ten (10) persons will win through this method.**

b] One (1) time every weekday between the hours of 3:00 p.m. and 7:00 p.m. for one (1) private code for 104.1 KRBE's Virtual Studio 104 featuring Kane Brown during a to be announced date in October. **ARV is twenty dollars (\$20).**

- 4. **Winner Selection.** The designated caller (as described above) and as determined by the Station in its sole discretion, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
